Growth, however, requires setting our sights on the next horizon. For Gartner, this means transitioning from a service provider to a shipbuilder.

We are raising capital to finance our entry into the custom yacht market through a unique business model focused on acquiring distressed yacht projects, construction, and resale. Our strategy is to leverage our considerable experience in naval architecture, engineering, and superyacht refit management to exploit a lucrative, unmet market opportunity.

Our Business

Gartner is a holding company with several operating businesses that provide specialized services for luxury yachts and naval vessels, including vessel refit, maintenance, technical services, and compliance certifications.

Our research and development activities include technologies such as Autonomous Underwater Vehicle systems for commercial applications and new fuel cell systems designed to improve efficiency while reducing harmful emissions.

Going forward, our objectives are to establish Gartner as a premium yacht brand, complete the development and commercialization of our intellectual property, and grow our diversified service portfolio.

Distressed Yachts

As a shipbuilder, we are focused on a lucrative but underserved segment of the luxury yacht market. New superyacht projects can face challenges due to various reasons, such as unforeseen financial difficulties, legal disputes, or even the unfortunate demise of the purchaser. In such instances, with a backlog of orders to fulfill, most shipyards are forced to abandon the project.

refit projects, we are entering the custom yacht construction market as the first shipbuilder focused solely on distressed superyacht projects.

Gartner's strategy is to leverage its considerable experience in naval architecture, engineering, and superyacht refit management to exploit this unmet market opportunity. As a purchaser of abandoned superyacht projects, we relieve the shipbuilder of the costs and liabilities associated with "mothballing" a vessel, while delivering a newly built custom yacht to buyers in less time and at a price comparable to the resale market.

We are in the initial stages of our first distressed yacht project, PK 50M, a 50-meter superyacht hull design and superstructure. We plan to use institutional financing for project acquisition and initial construction costs and are evaluating funding proposals from distressed asset funds and family office investment firms.

The success of our first project will establish Gartner as a new brand and secure the funding needed to grow our production capacity and deliver at least five custom vessels each year at scale.
